**MASTER STIPULATION AND ORDER DISMISSING WITH PREJUDICE CLAIMS
PURSUANT TO ZYDUS STATES SETTLEMENT AGREEMENT**

IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned counsel of record for the Plaintiff Subdivisions identified in Appendix A (collectively, the “Dismissing Plaintiffs”) and Defendant Zydus Pharmaceuticals (USA) Inc. (collectively and together with the Released Entities¹, the “Zydus Entities”) that, pursuant to the election of each Dismissing Plaintiff to participate in the Zydus States Settlement Agreement, which is dated April 4, 2025, as amended, and is binding on the Dismissing Plaintiffs and Zydus Pharmaceuticals (USA) Inc., and which has an Effective Date of January 29, 2026, all claims of each Dismissing Plaintiff against any Zydus Entity, including any entity identified on the attached Appendix C, are hereby voluntarily **DISMISSED WITH PREJUDICE**, with each party to bear its own costs.
